

Various field sampling plans (FSPs) describing soil sampling to be conducted under Unreclaimed and Insufficiently Reclaimed Sites Scopes of Work were approved with references to specific Quality Assurance Project Plans (QAPPs). Sampling was not readily achievable at select sites during the sampling season when the FSP was approved, and QAPPs have been updated annually.

PROPOSED MODIFICATION:

Site soil sampling will be completed, analyzed, and data validated as described in the latest approved version of the appropriate sampling protocol of the corresponding sampling year, superseding the QAPP referenced in the FSP.

For example, all sampling completed at Insufficiently Reclaimed Sites during the 2024 sampling season will be performed as described in the BPSOU 2024 Final Insufficiently Reclaimed Sites QAPP (Atlantic Richfield Company 2024), upon Agency approval of the referenced QAPP. Similarly, all sampling completed at Unreclaimed Sites during the 2024 sampling season will be performed as described in the BPSOU 2024 Final Unreclaimed Sites QAPP (Atlantic Richfield Company, 2024) upon Agency approval of the referenced QAPP.
